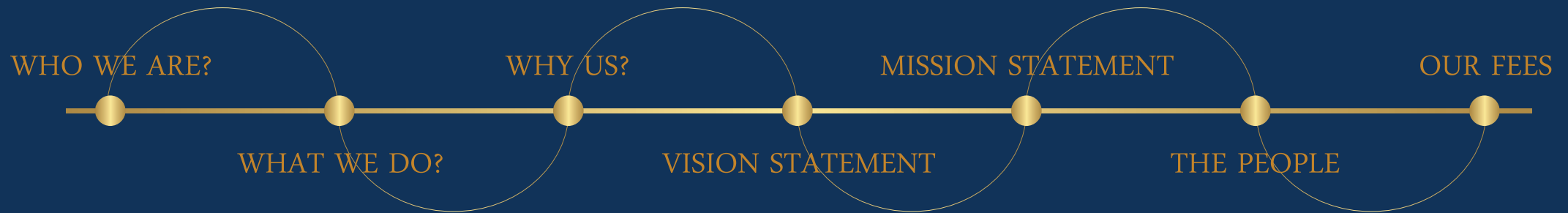

OUR FEES

We have two major categories of fees:
